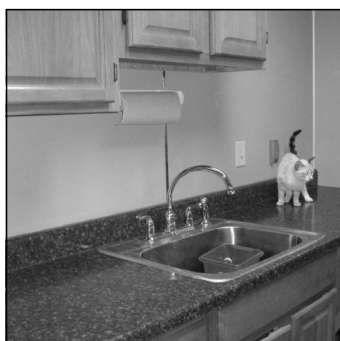
Rocky, a spry pug/dachshund mix and Sadie, a sweet, mostly deaf Dalmatian, are now two very fortunate

Thanks to those who contributed so generously to our much needed cat room repair fund, renovations have been underway since October. We are hoping our new look will be completed by the end of the year.

18 linear feet of cabinets and countertops have been installed, seven windows have been replaced, and little by little the smaller repairs, such as new shelving in the condos and patching and painting of cinder block steps, are being

completed. The final and most difficult re-do will be the floors. They will need to withstand an awful lot of people and cat traffic, since the cat room is always abuzz with activity.

A record year



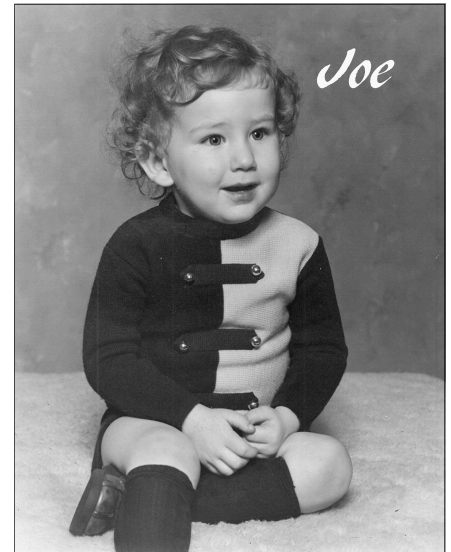

A haunting journey



Iris, a beautiful six month old kitten, discovered frightened, injured, and alone, arrived at Hillside where we subsequently discovered she had endured the unthinkable — she was viciously sexually assaulted with an unknown object that inflicted serious injury to her female area.

Featured on our website and Facebook page, Iris quickly received worldwide attention and concern with lots of “shares” and well-wishes. Donations for her medical care came pouring in to Joe’s Fund which is set up specifically to cover all medical needs for every animal at the Hillside.

Iris’ story inspired a loving community, both in the US and worldwide, with supporters reaching out to family, friends, and contacts on Facebook to form an international network of love, prayer, community and financial support for Iris and her caregivers.

In addition to our own website and Facebook page, *LifeWithCats.tv*, a cat advocate video show and source of cat news on the Internet, also publicized Iris’ story and kept everyone updated on her progress.

And so began Iris’ journey which has been filled with both despair and hope.

Initially, having suffered such serious injury, we were thankful her urinary tract was not punctured. After several weeks she began healing and finally acting like a kitten exploring her surroundings and enthusiastically batting toys around.

Sadly, bladder control became an issue and although she used the litter box when in her little private space, she had leakage, which our vet thought would lessen as her healing progressed.

With many vet visits ahead of her while she suffered from urinary tract infections, we remained hopeful because beautiful little Iris, with a personality to match, deserved a full recovery and her own happy, forever home.

Iris became well enough to be spayed but still could not entirely control her urine. Luckily for her, a very compassionate couple, softies when it comes to handicapped or needy cats, had been following her story. Lisa and Andy Konkus wanted to adopt Iris! They fell in love with her the instant they met her and were determined to do whatever it took to make Iris a happy, balanced kitty — no matter what.

The trauma Iris endured during the depraved assault left her scarred physically and emotionally. Unfortunately, even after an intensive investigation, we were unable to track down the fiend who attacked Iris.

In the loving home of Lisa and Andy, along with their other kitties and a beagle, Iris’ emotional scars began healing, but her physical problems remained a challenge. Iris needed to be seen by a specialist and a few months later was examined at a specialized vet referral clinic.

The vets there were truly shocked at her condition having never seen such degree of injury in a cat. Scar tissue around her female part almost covered the opening, and they felt certain there was more damage inside. A series of tests would be performed to get a better idea if reconstructive surgery would be an option, albeit a risky one.

Returning to the clinic this summer, accompanied by her new “parents” Lisa and Andy and foster mom, Sylvia, Iris underwent eight hours of additional invasive testing during which radiologists discovered a birth defect in Iris’ bladder. Combined with the damage done by her assault, it was causing incontinence issues which would simply have to be dealt with. Surgery was not an option.

Various medications were tried to no avail. Disappointed but not undaunted, the Konkuses became determined to love and pamper Iris even more, as if that was possible! They would deal with whatever needed to be dealt with. They planned to explore acupuncture and traditional herbal medicine, and we anxiously await results from that.

Iris’ worldwide fans are also disappointed that Iris could not be made physically whole. However, we all take solace in the fact that Lisa’s and Andy’s loving care has overcome the emotional scarring which resulted from that horrible day in March 2011 when Iris’ young life was changed forever.

Imagine, a sweet little gray cat from Hillside touching the hearts of people from all corners of the earth! Iris’ story will remain in many hearts forever, and everyone who loves Iris will remain in our hearts, too. On behalf of Iris, we say thank you everyone, thank you world!

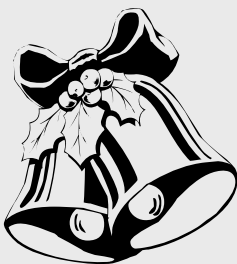

We feel like we are at “ground zero” with the massive amount of animals who need our help; it is so overwhelming we cry everyday, but because of you, we have survived another year — our 26th.

As we enter this holiday season, think of all the animals, snuggled safely in warm beds, with full tummies, not dreaming of sugarplums but of you — and the way you have made it possible for them to have a second chance at life, a chance to be loved.

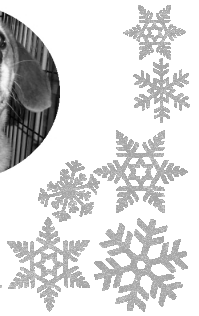

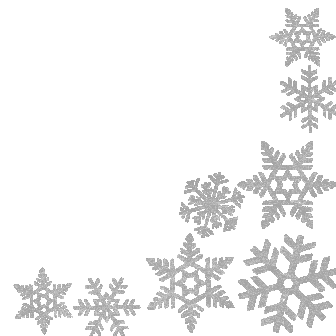
