When his owners brought him in, we were shocked and horrified to see his condition. He was trembling and

"About a week ago." they replied...


I truly cannot imagine the pain he endured for so long with no one helping him. When the time came to transport him, we were very cautious moving him into our van because an animal who is in such pain and fear can be very upset and become aggressive to complete strangers. Max looked at us with his beautiful trusting eyes and somehow knew we were going to help him. We picked him up and he just lovingly gazed at us — no growling or snapping.

We rushed him to the vet where he was examined and we were given bad news; his leg was shattered so severely he would require orthopedic surgery. Fortunately, Max could be treated at North East Emergency Clinic in Wilkes-Barre, PA. The cost would run between \$3,000 and \$4,000. Thanks to Joe's Fund, Max could get his surgery, but equally important, Max would require placement in a foster home for at least six weeks after surgery because of the extent of the operation and the care, peace, and quiet needed for successful recovery.

Since my entire staff has a mini-shelter at their homes, none of us were suitable foster candidates. We immediately turned to the internet and put out an appeal for a qualified foster home. Within hours, a blessed person offered to take Max in during his recovery. Our first feat

accomplished, it was on to scheduling Max's surgery!

My Joe is smiling in this picture (one of my favorites) because of you, our faithful and



loving supporters who gave to his fund to make it possible to save this poor dog who did not know one good day in his life. Your kindness has made the difference between life and death for Max and so, SO many others. For that I can never thank you enough. I didn't have to hold Max in my arms and say, "I'm sorry, we can't afford to fix you."

Because of you, it IS "A Wonderful Life" (Joe's favorite movie)! Max will walk again and be in a new home for Christmas getting all the love he deserves. Max's blessed foster mom and dad love him so much they've decided he will be spending his first loving Christmas — as well as the rest of his life — with them!

Joe's, my, and our buddies, wish you the merriest Christmas — like Max will have. We hope you always know the difference you have made in our buddies' lives and just how much I love and appreciate you — more than words can ever express!

A great big "Thank You" goes to all who contacted state legislators urging them to


ban those "jaws of pain." Taking a stance with our elected officials is the only way we can stop the horrible suffering endured by cats and other animals that will surely keep occurring.



### WINTER PET HEALTH TIPS

Pay special attention to your pet and remember the following:

- Antifreeze, which often collects on driveways and roadways, is highly poisonous and can be lethal.
- Rock salt may irritate footpads. Rinse and dry your pet's feet after a walk.
- Provide plenty of fresh water.
   Dehydration occurs in the winter, too.
   Snow is not a satisfactory substitute for water.
- To prevent frostbite on ears, tail and feet, limit your pet's exposure to the outdoors.
- Supplemental heat sources can easily burn your pet. Make sure all fireplaces have screens and keep portable heaters out of reach.
- Like people, pets seem to be more susceptible to illness in the winter.
   Take your pet to a veterinarian if you see any suspicious symptoms.
- Don't use over-the-counter medications on your pet without consulting a veterinarian.
